Customs to launch revised AEO Programme offers a Comprehensive unified trade facilitation

It is almost a decade back, Indian Customs Risk introduced Management System (RMS) in Customs clearances. Introduction of Risk Management System (RMS) in imports during 2005, changed the whole clearance process scenario. Accordingly, importers/exporters can make declarations regarding classification, value and the Electronic Data Interchange System processes the bill for assessments on the basis of these self-declarations. Duty is assessed in less than three minutes on the basis of the declarations and the Challan indicating the amount of customs duty payable is generated. The duty amount indicated has to be paid through online banking system and then importers/exporters to proceed to the Customs area (port/CFS/Airport) the for presenting documents and for obtaining the clearance from Customs. The RMS procedure was extended to Exports also during 2013. CBEC had gone ahead to launch two new schemes Accredited Clients Programme (ACP) and Authorized Economic Operators (AEO) programme. The former one, ACP provides an assured facilitation to importers who are assessed as highly compliant where as the later one, AEO is with a common objective of ensuring security in global supply chain to all the stake holders such 25 Importers, Exporters, Warehouse owners, Customs Brokers ,Logistic Service Providers Custodians, Terminal operators etc. For a better understanding, the broad benefits under both the Schemes. proposes to merge the two facilitation schemes into a revised and combined three-tier AEO programme and proposes enhancement in the scope of these programmes so as to provide further benefits to the stake holders who have demonstrated strong internal control system and willingness to comply with the laws . Under the leadership of the Prime Minister of India Mr. Narendra Modi, with the increased focus on "Ease of Doing Business", it has become imperative to develop a comprehensive unified trade facilitation programme bv incorporating the existing ACP scheme and ongoing AEO programme into a revised AEO programme

AEO Programme: The objective continues to remain same as earlier that is to provide businesses with an internationally recognized quality mark which will indicate their secure role in the international supply chain and that their Customs procedures are efficient and compliant. An entity with an AEO status would be considered as a 'secure trader' and a 'reliable trading partner'.

Three-tier Certification: - There are two broad types of beneficiaries in the Scheme (1) Importers Exporters and (2) Other economic operators. revised AEO The Programme offers three tiers of certification to the stake holders in the international trade. The scope of the benefits to the AEOs based on their categories are mentioned in Table 2:

Status of the existing

ACP and AEO certificate holders: All the existing AEOs shall be granted AEO (Tier-Two) Certificate by the AEO Manager Programme within 15 days of launching the Programme. Similarly, all the existing ACP clients shall be provisionally granted AEO (Tier-One) Certificate by the AEO Programme Manager .

Who can Apply for AEO Status ? - Anyone involved in the international supply chain that undertakes Customs related activity in India can apply for AEO status irrespective of size of the business. These may include exporters, importers, logistic providers (e.g. carriers, airlines, freight forwarders, etc.), Custodians or Terminal Operators, Customs House
